City Manager Corner

As Brentwood prepares to celebrate its 50th year as a city, there will be many opportunities for residents to look back at the growth of this community over the last half century. For some city employees, the trip down memory lane includes looking back to the days when

City Hall used to be where the Local Taco is today on Pewitt Drive or when the library was in the small house on the campus of Brentwood United Methodist Church.

We have come far from the good old days. We now have an award-winning library, almost 1,000 acres of parkland, many miles of trails, and four fire stations. However, as we celebrate the past in 2019, we also have to look to the next fifty years when planning how to serve the needs of Brentwood residents.

Brentwood City Hall in Maryland Farms is home to all of the City's administrative offices, police functions, and Fire Station #1. The presence of the Police Department within City Hall presents both space and security challenges. If you came to apply for a job or meet with the Mayor, there is a decent chance you might see a suspect being walked through City Hall since the Police Department is broken up into four different areas on two floors of City Hall. As we move into 2019, the City will be finalizing plans to construct a new Police Headquarters on land next to the Williamson County Recreation Center on Heritage Way. If plans stay on schedule, the new facility could be open in time for the Police Department's 50th anniversary

in 2021.

When it comes to the services provided by the Fire and Rescue Department, time is of vital importance. With the continued growth in the number of emergency response calls, as well as the geographic size of the City, we have identified the need for a fifth fire station in the Split Log Road area. We hope to have property purchased by the end of 2018 and begin planning for construction of the new station sometime in the next three to five years.

Finally, we have begun planning for construction of a Parks Department office building within Crockett Park. Moving the Parks Department from the Service Center in the Cool Springs area will save staff time by having the admin offices in the same location where the maintenance equipment is stored, and make the department more accessible to the public.

We certainly hope all Brentwood residents will take part in our many 50th Anniversary events planned during 2019. While you learn about Brentwood's history, be assured that we are also looking ahead to the next fifty years.

The Street Scoop

Crews resurfaced more than 23 miles of road in 2018 and have many more miles on the 2019 list. The complete 2019 street paving list can be found on our website:

Other 2018 Public Works Department accomplishments included the construction of a new roundabout on Crockett Road at Raintree Parkway/Green Hill Blvd, a new traffic signal at Split Log and Ragsdale Road and construction continues with the completion of the new bridge on Sunset Road as part of the Sunset and Ragsdale Road Realignment. When construction is completed later this year, the project will include a three-lane curb and gutter roadway with a center turn lane and a 10' bike/pedestrian path.

The TN Department of Transportation continues its widening project along Franklin Road from Concord Road south to Moores Lane. Crews started work in Fall 2017 and still have two-three years left to complete. The widening improvements will relieve congestion, improve safety, and accommodate growth.

Coming Soon:

- Sidewalk along Split Log Road from Tuscany Hills to Jordan Elementary School
- Repair and resurfacing to at least 35 roads
- Wildwood Valley Bridge Resurfacing
- Multiuse path along Crockett Road from the Witherspoon subdivision to Aberdeen at the entrance to Crockett Park and Crockett Elementary School

Citywide Brush Collection

The City of Brentwood offers brush collection once a month to all residents on residential streets. This service costs the city roughly \$500,000 annually. To continue this free service, we ask that you follow the rules. We are also beginning to implement the use of PAPER bags only for collection.

Chipper Rules

1. Brush must be behind the curb with cut ends towards the curb.
2. Brush must not exceed eight feet in length and three feet in height.
3. Limbs and stumps larger than six inches in diameter will not be picked up.
4. Debris that is the byproduct of commercial cutting/trimming will not be accepted.
5. Leaves and grass clippings will be collected in brown paper bags only. Plastic bags will not be accepted.
6. Do not stack brush, clippings or other leaves near stationary objects like a fire hydrant, mailbox, utility pole, etc.

**Homeowners will receive a door hanger, with the violation marked, if a pile violates the rules.

Water Meter Reading System Upgrades

The Department is currently upgrading the City's existing "walk by" meter reading system with an advanced Sensus Flexnet reading system. The Flexnet system includes installation of multiple tower sites that read meters remotely as opposed to the more labor intensive "walk by" reading system. The base infrastructure includes three tower sites which have been reading a small sample of meters for several years now.

The Flexnet system works to provide the customer and department staff enhanced reading data (greater accuracy measurement of water moving through the meter). This increases operational efficiency and decreases operational costs as well as provide the customer with greater usage information which aids the customer in reducing water waste and potentially avoid costly plumbing repairs. City staff uses the enhanced metering data in capital project planning and customer support.

Devens Drive Water Line Replacement Project

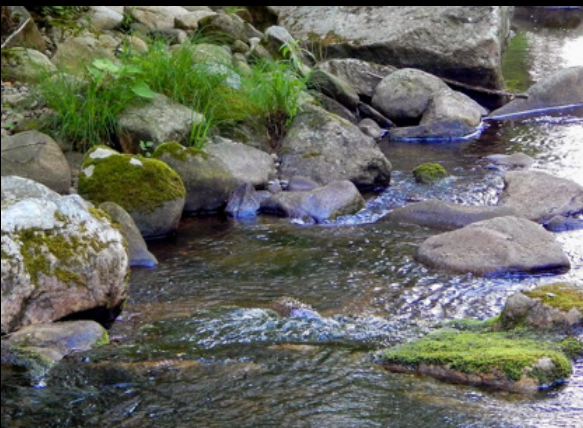
(Knox Valley Dr. to Wikle Rd. East)

The Water Services Department's water line replacement program is focused on incremental replacement of aging water lines to maintain the highest level of distribution service, reduce maintenance costs and avoid significant future capital infrastructure costs.

The next area of water lines slated for replacement includes those located along Devens Drive, between Knox Valley Dr. and Wikle Rd. East. The project includes side streets: Lynhurst Ct., Glover Ct. (not Glover Dr.), Brentview Ct., Foxview Ct., Sherwood Green Ct. and Wikle Rd. East (the cul-de-sac east of Devens). Project Status: Design for this project began in July 2018 with construction tentatively scheduled for spring - summer 2019.



What can you do to keep our storm water and our streams clean?



1. Never dump waste down a storm drain or into a drainage ditch.
2. Clean up after your pet.
3. Dispose of trash in approved containers.
4. Dispose of household hazardous wastes at designated locations. (See Household Hazardous Waste Disposal Day put on by Keep Williamson Beautiful)
5. Check your vehicles for leaks (Repair them!).
6. Recycle motor oil and other vehicle fluids.
7. Compost yard wastes.
8. Use fertilizer and pesticide only when needed (Read the label!).
9. If you wash your vehicle at home, wash it on the lawn rather than on pavement.
10. Report potential storm water pollution to 615-371-0080.

Two Close Calls for Brentwood Police Officers

The “Move Over Law,” which passed in 2006, is a part of the [State Law: Move Over for Stopped Emergency Vehicles] “Failure to Yield to Emergency Vehicles Law” (T.C.A. 55-8-132) and requires motorists to move over into the adjacent lane of traffic when safe to do so, or alternatively to slow down for emergency vehicles. In 2011, the law was expanded to include utility service equipment to the list of vehicles for which motorists are required to either slow down or move over. Tennessee was the 30th state to establish a move over law which creates a safety zone to protect police, firefighters, other emergency personnel, and utility workers.

The penalty for the first violation of this law is a Class B misdemeanor punishable by a fine of not less than one hundred dollars (\$100) nor more than five hundred dollars (\$500), or imprisonment not longer than thirty (30) days, or both.

On the morning of July 14th 2018, two Brentwood Police Officers were assisting a motorist on the shoulder of I-65 South at the 72 mile marker. Both cars were parked on the shoulder with emergency equipment activated when they were struck from behind by a vehicle traveling south. The initial impact was heavy causing extensive damage to the first Patrol car which was fortunately unoccupied. A second Patrol car was also damaged in the collision when the force of the first vehicle was pushed into the second. The second vehicle was occupied by the motorist who was being assisted who fortunately did not sustain any major injuries. The driver of the vehicle that struck the BPD units was arrested by THP at the scene for DUI.

This incident is a stark reminder of how dangerous working the interstate can be and reinforces the importance of the “Move Over Law”. Our Officers and the motorist we were assisting in this incident were lucky as evidenced by the extensive damage sustained to the two patrol cars. We are forever mindful of Metro Officers Christy Jo Dedman and Michael Petrina, among others, who lost their lives in similar situations where adherence to this law could have made a difference. Please think twice next time you pass a stopped emergency vehicle on the road.



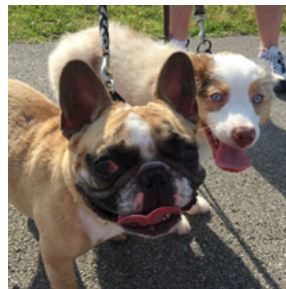

A Brief History of the John Holt Family

If you have driven by the Brentwood Library recently you may have noticed the name has been changed. Thanks to O'Delle Holt, widow of John Holt (b. 28Mar1890), and Charles W. Witherspoon, Jr. for their generous donation to the City of Brentwood.



In Article IV of her will, O'Delle Kelly Holt leaves a life estate in the John P. Holt farm to her nephew, Charles Witherspoon; after his death 1/2 of the estate would go to the City of Brentwood "provided" they name the existing library for her late husband or build a new library to be named for him.

A short history of the Holt family: In 1797 John Holt's ancestor, John Holt (b. ca 1760 in North Carolina), and his wife, Izabel Purkins Holt, traveled to Davidson County, Tennessee in an ox cart with their four children: Harden Perkins, Mary Polly, William N., and Edith P. They would have eight more children in Tennessee - making an even dozen!



On 10Apr1797 Izabel's brother, Nicholas Perkins Hardeman, conveyed approximately 100 acres "in consideration of the natural love and affection he bears to his sister, Isbell Holt wife of s'd John and also for and in consideration of the sum of five shillings" a certain tract of land in the county of Davidson on the waters of Mill Creek "...containing by estimation one hundred acres be the same more or less."

John and Isabella lived in close proximity to her brother for about 10 years. John then sold the one hundred acres to Thomas Edmiston for \$1,000.00 on 22Sep1808.

Less than a month later, on 10Oct1808 Thomas Edmiston sold to John Holt 222 acres in Williamson County for \$1,350.00. This 222 acres was part of the 640 acre land grant Thomas Edmiston received from the State of North Carolina 17Apr1786. The clerk of the Williamson County Clerk's

office where the deed was registered was N. P. Hardiman. Thus began the John Holt farm in Williamson County.

Dr. Albert L. Cooper, published a book titled: Ancestors and Descendants of John and Isabel Holt in 1971. The book is available at the Tennessee State Library and Archives in downtown Nashville.

"Before her marriage to John, Isabel was a Hardeman. Her mother was Mary Perkins." One of the eight children born in Williamson County to John and Isabella was Thomas Holt was (b. 1802). He married Rosanna Julia Herbert. Their son, Lewis Herbert Holt, was born in 1843. Lewis married Almira Page, the daughter of John Page. Lewis and Almira/Elmira became the parents of seven children – one of whom was Kate born on Christmas Day 1886.

Kate married Charles Witherspoon. Kate died 19Dec1939 of congestive heart failure at the age of 52 years 11 months and 24 days. Their only child was Charles Witherspoon, Jr. born 28Nov1926.

Charles lived with his aunt O'Delle Kelly and uncle John P. Holt all his life. John P. Holt died 21Sep1984. O'Delle lived at Holtland/Wildwood until 1993. Charles lived on the Holtland/Wildwood property until his death on 09Aug2017.



Did you know?



The Palms Dinner Club was a happening place in the 1930-40s. It was located where the Exxon Station was on Franklin Road next to Corky's. Of all the nightclubs, The Palms was the most prestigious with dining, dancing, and gambling.

What's Being Built in the City?



Hill Center Development Phase 1

May 17th, 2018 marked the official grand opening of Phase 1 Hill Center Brentwood. Tennessee Governor Bill Haslam attended the event which also marked the groundbreaking for phase II which includes plans for an AC Hotel, a boutique hotel chain through Marriott.

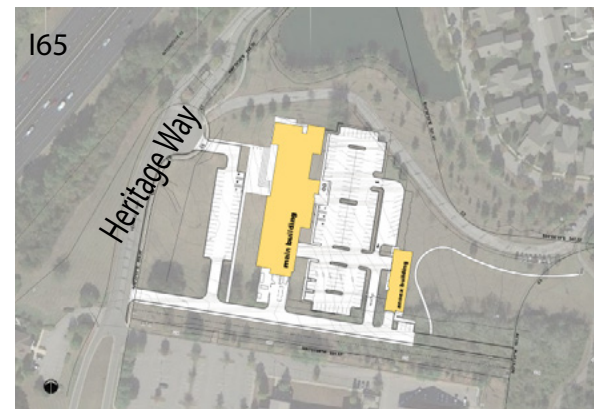
Phase II is also slated to include more parking and offices as well as a walking trail that connects to Maryland Way Park in the rear of the center.

New Brentwood Police Headquarters

Sometime in 2021, The Brentwood Police Department will move to a new facility that is currently being designed. The location of the new facility will be on Heritage Way just north of the Williamson County Indoor Sports Complex.

The approximately 50,000 square foot building is needed to serve the community today and for the next thirty years. Preliminary cost estimates are around \$20 million. All police operations, including the 911 dispatch center, would be in the building. An indoor firing range is also included in the plans and the facility will include a community meeting room to also serve as the municipal courtroom.

City staff are working with the design team from The Architect Workshop on the interior and exterior layout building design and elevations. Once a final design is accepted, work will begin on a development plan. The city hopes to break ground in early 2019.



Future Splashpad

The City of Brentwood is working with the Williamson County Parks and Recreation Department to build a 9,000 square foot splashpad located outdoors at the Williamson County Indoor Sports Complex at 920 Heritage Way. The \$6.6 million renovation would also include the first pickleball courts in Brentwood, a group fitness room, childcare facility, basketball courts, and additional parking. Brentwood's investment would be a one-time investment of \$1.5 million if approved. The earliest the splashpad could open is mid-2019 if all is approved.

Original Hill Center Renovation

The facelift is almost complete at the original portion of Hill Center, housing Puffy Muffin, Hallmark, REI and others. Varying facades, metal awnings and a small outdoor seating area at Fresh Market are all in various phases of construction. Each store will remain open during the renovations with protected entrances to avoid construction.



Brentwood Place Shopping Center

Chick-Fil-A is expanding its kitchen and increasing the size of the previously approved order canopy on the south side of the building and adding a delivery canopy on the north side of the building. Other improvements to the site include reconfiguring the parking lot providing crosswalks and signage to assist with pedestrian and traffic flow around the site. Finally, a modified driveway connection and adding an additional lane will also enhance traffic flow entering the shopping center.

City of Brentwood Awards More Funding to Schools and Recreation Providers in 2019

Funding for all Programs Totals \$341,100

For the past 32 years, The City of Brentwood has awarded more than \$5.5 million dollars to Brentwood schools located within Williamson County Schools. Schools use the money for non-recurring costs such as books, technology, and special projects. At its regular City Commission Meeting on Monday August 27, 2018, the City presented representatives from twelve Brentwood schools with checks for \$239,100. This year's total is up 6% or \$14,100 more from last year. The City presented

four recreation and senior center service providers with a total of \$102,000. That amount is 17% more than Fiscal Year 2018 and the first increase in ten years.

Park Lights Controlled Using Cost Saving Technology

With the days getting shorter, how does the City control the recreational facility lights in Brentwood Parks? We use technology called Control-Link. The remote system helps us control, monitor, and manage the lights by directly controlling athletic field lighting via a website. This technology is currently used on Crockett Park, Tower Park, and Granny White Park fields, making it easier to operate more efficiently and saving tax payers dollars by not having to rely on employees to manually operate the lights.

Can you hear me now?: City Receives First Small Cell Application

Brentwood is in the process of implementing its first small cell application since the State of Tennessee, as well as many other states across the country, recently adopted new laws that provide for the installation of such facilities in the public right-of-way. Small cell facilities are miniature versions of large cell phone towers. The small cell facilities are the latest in technology designed to help meet the increasing demand for wireless service. These smaller facilities are designed and located in areas of high use and are intended to improve service in specific areas where there is a large concentration of cell users. These facilities are typically mounted on existing street light poles and designed to blend in with the existing area.



Brentwood received its first application in August 2018 which was approved at the September 4 Planning Commission meeting. The new small cell tower will be located on Crossroads Boulevard and will look much like the picture. City staff continue to work to

adopt specific local regulations to ensure the installation of these facilities is done while meeting the regulations set by the state.

Brentwood's New Population: 43,889

The State of Tennessee distributes tax proceeds to municipalities like Brentwood and counties based on population as reported by the U.S. Census Bureau at the beginning of each decade. Municipalities and counties are permitted to conduct a special census to document population change between the federal censuses. Municipalities may conduct up to four citywide special censuses during the decade. 43,889 is the new certified population for Brentwood following the Special Census conducted in 2017-18 by the Planning and Codes Department.

With the new state certified population, we are set to receive approximately \$436,000 per year.

The additional funding will be used to fund essential services such as fire and police protection, street maintenance, the Library, Parks, etc. Also, the additional funding helps the City to maintain the current level of City service while also maintaining a low property tax rate for our residents.

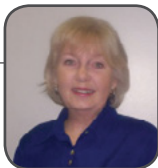
