Guidelines for Issuance of Construction-Related Permits

PLUMBING PERMITS:

- Contractors pulling Plumbing Permits <u>shall</u> be a Tennessee State Licensed Contractor with a plumbing designation **LLP**, **CMC-A**, **MC-A**, **CMC** or **MC**. This plumbing work shall be performed by the Plumber who pulled the permit.
- A Homeowner *may* pull the Plumbing Permit to do work on his/her own home, but shall sign an affidavit in this office stating that they will be performing the plumbing work themselves on the home that they legally own. This plumbing work shall be performed by the Homeowner who pulled the permit.

◆ ALL OTHER BUILDING-RELATED PERMITS ISSUED BY THE CITY:

- The Contractor pulling the permit(s) shall either have a State of Tennessee contractor's license for the specific type of work being applied for <u>OR</u> may pull a permit without a contractor's license <u>IF</u> the job is "Up to and including \$25,000." Contact the State Contractors Board (615-741-8307) for possible percentage increase allowance, above the \$25,000 limit.
- After meeting the above stipulation, the Contractor must either provide proof of Worker's Compensation Insurance if he/she has <u>any</u> employees (certificate must list City of Brentwood as the Certificate Holder). If the Contractor is a sole proprietor OR a partnership and chooses not to have Worker's Compensation Insurance, they must obtain a Worker's Compensation Exemption with the State of TN.
- The City of Brentwood has a requirement of a Business Tax License if: 1) your office is in Brentwood; 2) your office is outside the State of Tennessee; or, 3) if and when you contract work in Brentwood \$50,000 or more in a single fiscal year. - After meeting these three stipulations, and the permit is approved, paid for, signed for, and picked up by the Contractor (or his/her W2 paid representative - employee), this Contractor may subcontract any and all of the work under this permit to a valid Subcontractor. At this point the Contractor is operating under "Building Contractor Laws & Regulations set forth by the Tennessee Department of Commerce & Insurance" and must follow those laws, rules & regulations when hiring a Subcontractor. The City of Brentwood does not monitor this sub-contracting. Exceptions apply to contractors performing work on homes built prior to 1978. See <u>EPA</u> <u>Lead-Based Paint Requirements</u>.

+ ELECTRICAL PERMITS ARE ISSUED BY THE STATE OF TENNESSEE

All electrical permits are issued by agents for the State of Tennessee.
