water. The gutters drain directly onto the sidewalk
creating a serious danger to anyone using the
sidewalk, since it is often slippery as a result. The
water causes mold/mildew/slime to grow on the
sidewalk in warm weather, and in cold weather the
sidewalk gets very icy, which is dangerous for
everyone but particularly for those who are less
steady on their feet, or use canes, walkers or
wheelchairs. Other buildings have covered metal
channels mounted into and flush with the sidewalk,
which carry the rainwater from the gutter to the
parking lot. But this building does not. (And of
