Brentwood is Finalist in National Communication Award for COVID-19 Public Relations Campaign

Deanna Lambert, Brentwood's Community Relations Director, represented the City at the 33rd annual conference held September 8- 10 in St. Louis, Missouri.

The Savvy Awards, held in conjunction with 3CMA's Annual Conference, recognize outstanding local government achievements in communications, public-sector marketing, and citizen-government relationships. The award was presented to Brentwood's Community Relations Department for a new category for 2020 that focused specifically on digital interactive communication efforts during the COVID-19 pandemic for cities up to 45,000 in population.

Brentwood's entry highlighted various videos produced throughout the



COVID-19 pandemic. Judges said, "Brentwood's COVID PR Campaign did a great job breaking through the noise surrounding Covid. It was impressive to see they received over 60 questions from their live sessions, while also finding new cost-effective software to aid in the discussion was innovative." The video platform judges referenced cost the city \$240 per year and allows multiple people to talk on screen while sitting in separate areas.

The entry also included one special video about a little boy celebrating his birthday during the pandemic lockdown. His grandfather in Florida called in a special birthday wish from the Brentwood Police Department. Watch "BPD Delivers Special Happy Birthday Message" on YouTube. "Involving the city police in the little boy's special day produced a tear from this crusty government official. The police singing through speakers was hilarious! remember his Covid birthday! The city presented a great mix of six videos! I applaud your efforts to mix serious and humorous to convey important information."

Assistant City Manager Jay Evans complimented staff's tireless work in a very busy year for government communications, saying, "the pandemic presented a unique set of challenges in 2020 that required outside-the-

box solutions. There is no doubt we upped our communications game when the community needed it most."

The City of Brentwood last won two Savvy Awards in 2019. One award was for the promotional video category for the Brentwood at 50 Years documentary that showcased the city during its 50th anniversary celebration. The other award was presented for Brentwood Celebrates 50 Years and earned the first place Savvy Award in the Special Events - One-Time Event category. The award entry included a synopsis of the yearlong celebration of Brentwood's 50 years as a city which included the goal of the celebration, examples of social media and traditional media coverage and event attendance.

Earlier this year, the City of Brentwood implemented an electronic business system that provides for the sending and receiving of electronic records that contain electronic signatures and/or authorizations. Bottom line, this will mean a faster process for our contract process for departments and vendors. Staff will no longer have to print multiple copies of contracts and distribute throughout the City. This will save staff time preparing physical documents, envelopes, scheduling pickup and drop off times of physical documents, as well as the actual postage cost and paper.

Several times within the past couple of years, the City has been notified by vendors that they would have submitted a bid, had the City had been capable of accepting electronic submittals, but the vendor's cost to submit "hard" copies was prohibitive. The City believes that the implementation of this software/process will enhance the City's ability to receive the most responsible, and competitive bidders for its proposals.

Since his retirement, Engineer Jason Pierce has stepped into the role of overseeing the radio/communications program for BFR. While the radio system is new, he continues to work tirelessly to ensure the radios and headsets in the apparatus work efficiently and effectively. He has made great sacrifices, both on duty and off, representing the City of Brentwood as a member of the Williamson County Fire/EMS User Advisory Group. He has conducted trainings not only within the department, but also across several



departments within the city and county. Engineer Pierce received a Letter of Commendation from Jay Bonson, the Williamson County Fire Coordinator. This was in recognition of the hours he donated to assist their agency with radio communications.

For his ongoing dedication and tireless efforts to continually improve our department's performance and efficiency, Engineer Jason Pierce has been nominated for, and received, the Medal of Merit.

CIVIC AWARD Stine

The Civic Award recognizes members who have performed a civic service and –through their efforts-assisted, educated or provided financial relief for a worthy cause.

Engineer Paul Stine demonstrates exceptional dedication to selfless service within the community. They also learn about fire safety, complete the Firefighter Challenge, and engage with emergency workers on Family Safety Day. Engineer Stine has volunteered at similar camps for over 10 years, in both California and Tennessee. His service to the public far exceeds his duty as a firefighter.

Brentwood Leaders Break Ground on City's Fifth Fire Station

On Friday, September 10, the City of Brentwood Mayor and Commissioners, along with the City Manager, Brentwood Fire & Rescue Department leaders, and design and construction teams celebrated by breaking ground on the City's fifth fire station facility. The \$9 million project will place the City's newest station in the fast-growing, southeast portion of Brentwood at 9551 Split Log Road.

The new two-bay fire station will be two stories and house a single company, which is a three-person fire crew. It will include one front-line fire engine and one reserve apparatus. The building will be approximately 10,000 square feet, will contain a public restroom and water fountains for people and pets using the park trail system.

Brentwood based TMPartners is the architectural design firm who worked with City Manager Kirk Bednar and other city leaders to create the building programming, design, and facility analysis. Throughout the project, they will oversee the schedule development, cost control, and project management. American Constructors, Inc., also of Brentwood, was hired to serve as the construction manager. At this time, the total construction cost is currently projected at \$6.9 million, pending any rising construction material costs. Construction is anticipated to take approximately one year.

Brentwood Fire Chief Brian Goss explained the need for a fire station in this part of the City. "Statistics show a 21% increase in call volume in this area this calendar year, and we anticipate that will continue to grow as further development takes place. The city places an extremely high priority on public safety, and this project is an example of that commitment," Goss said.

Primm House Historic Property and Primm Farms Subdivision Plans Moving Forward

The following summary is taken from a talk prepared by Brentwood Historic Commission member, Kathie Greaves, for the unveiling of the Primm House paintings which took place in August at the John P. Holt Brentwood Library. Essential questions remain unanswered: Who built the house, expanded the house, and built the slave cabins?

"For years we have known the historic house across from Boiling Spring Academy on Moores Lane as the Owen-Primm house. In many local histories you will see this house is named the Owen-Primm house after the first owner Jabez Owen in 1806 and the last owners – the Primm family. With the addition of a nearby subdivison, the house was set for demolition, but thanks to the generosity of a preservation minded couple, Mark Tacchi and Bobbi Clemens, the house will remain.. But preservation is not only the logs and beams that make up the structure, but also the stories of those that lived there. With updated research the records were amiss for the history as has been handed down. A different history on early ownership was found and Jabez Owen wasn't included in it as the original owner.

Time to go back to the beginning. On 17 Apr 1786 the State of North Carolina made a land grant to William Collinsworth for 640 acres in Davidson County lying on the Little Harpeth River-Warrant no 315 and grant #43 which later contained the Primm Property and historic house as well as the Fewkes Mound site and Boiling Spring Academy site. Collinsworth never lived on the property and half of the grant (320 acres) which included the above Primm farm area was sold

to John Patton from North Carolina July 1799. John Patton had little time on his thriving property and died in 1808. His widow Sally Patton Orr and her second husband lived on the property until her death in 1835.

The portion of property containing the current Primm house known as the "Boiling Spring" tract was sold to the neighboring Wilson Family before 1840. It hasn't been determined if the Wilson's added the antebellum portion of the house to the original log cabin but it is a style of home the Wilson's might have built and lived in. In 1845 James H. Wilson sold the property to Sterling R. Thornton which he kept for 10 years before selling to Martha Virginia Owen (daughter of Jabez Owen) and her husband John Edmondson. John Edmondson was a slave owner and in 1860 had 3 slave dwellings on the property. If the house addition (and the slave cabins) had not been added to the original cabin by the Wilsons, it was most likely built by the Edmondsons. Martha Virginia Owen and John Edmondson never had children. John came to an unfortunate end early in life. During an altercation at a nearby wagon shop in November 1874, John was shot and killed. Martha continued to farm the property with the help of her brother-in-law William "Robert" Edmondson as overseer. After Martha's death in 1905, William "Robert" Edmondson was given a life estate on the property. After the death of William "Robert" Edmondson in 1917 the property was sold to John Womack.

John Womack and brother T.P. Womack owned the only legal distillery in Williamson County--White Maple Distillery in Franklin. After only 9 years of operation, the distillery was forced to close when Tennessee enacted its own statewide Prohibition with 1909 Senate Bill No. 11. Rumor has it that John Womack kept his distilling skills up and continued his craft of distilling "illegally" on the property.

The Primm family were early pioneers to the Liberty Church area. (Concord and Liberty Church Rd) Thomas Perkins Primm and his wife Myrtle Anne Layne Primm had a family of 12 children. They moved from Split Log Road to the Owen-Primm house in 1927. The Primms established their dairy farm and family remained there for almost the next 100 years. Charles Primm, son of Thomas, was the last Primm to live in the house and passed away in 2011."

Remembering 9/11: Brentwood Sisters Work to Keep Heroic Dad's Memory Alive

In honor of the 20th anniversary of Sept. 11 and the lives lost in the terrorist attacks on America, a local family recently shared the story of their father who died that day in the line of service to guests at the John P. Holt Brentwood Library.

Time is a funny thing. For sisters Lauren Fletcher and Kaitlynn Meisenheimer, 20 years ago seems more like a lifetime. However, for their family, the attack on the World Trade Center on Sept. 11, 2001, and the loss of their father on that tragic day also make it seem as if time has stopped.

Raymond "Ray" Meisenheimer, a firefighter with the New York Fire Department, Rescue Company 3 in the Bronx, was ending his shift the morning of 9/11. He put his gear in his truck to head to his next job at the fire academy and only went back into the fire station to ask someone to move their car. That's when the alarm went off. The World Trade Center was under attack. Meisenheimer's station was the second rescue company on the scene. They went into the south tower close to where the plane had hit. All communications were down.

Fletcher was a freshman in high school and vividly remembers her mother picking her up from school. She also remembers thinking she understood why other students whose parents worked in the World Trade Center were called to the office, however, her dad was in

Kaitlynn Meisenheimer, a seventh grader at the time, has a different memory. She stayed at school, remembering that by the end of the day, there were only a few students left in her class. "I remember hearing the words 'a terrorist attack,' 'two planes,'" she said. That evening, the sisters watched the news with their mom and saw the magnitude of what had happened. There was no communication, and they stayed glued to the TV. Both remember phone calls from other upset wives and trying to keep hope alive.

Fletcher knew their worst nightmare had come true when her mother's screaming began at about 3 a.m. Seven members of the Rescue 3 team and a captain from Rescue 1 who was filling in for another firefighter lost their lives when the World Trade Center towers collapsed. From the moment they learned of their father's fate, the sisters and their mother were surrounded by other firefighters and assigned a liaison to help them navigate moving forward. They visited the fire house where they met their dad's other family. "At that point, keeping dad's memory alive became our goal," Fletcher said. "I told anyone that would listen about my dad. Twenty years later, he still has a story."

It became a full-time job managing fundraising and events to keep their father's memory alive, from TV appearances to magazine articles in Teen Cosmopolitan and proclamations — in Hawaii, June 15 is Ray Meisenheimer Day. They also began Run for Ray in 2013, and it continues today in multiple locations. A 5K was even run in his memory in Afghanistan. The sisters were also called to appear on morning television when Osama Bin Laden was killed.

Fletcher is married to Brien Fletcher, who works with the Brentwood Police Department. They moved to Middle Tennessee in 2016, and Kaitlynn Meisenheimer soon followed. She's a teacher at Jordan Elementary School in Brentwood.

Public Works: Sweeping on a City Street Near You

The Public Works Department continues to improve upon the existing Brush Collection Program (Chipper Service), due to quickly increasing costs for labor, equipment maintenance, debris disposal, and worker's potential for injury, the department has been moving away from the labor intensive woodchippers. Over the past two years we have implemented the use of four hydraulic grapple arm trucks to remove brush more safely and efficiently, from residential properties. Please familiarize yourself with the schedule and program rules on our website brentwoodtn.gov/departments/public-works/chipper-service. Because of the evolving nature of our program and the equipment being used to facilitate brush collection, it is imperative that brush piles be a minimum of 5' from any fixed objects (e.g. mailboxes, fire hydrants, utility pedestals, light/power poles, headwalls, etc.). It is also requested that you not pile brush directly under low hanging limbs, so that the hydraulic arm can collect the pile without damaging your tree.

Public Works has also recently purchased a street sweeper making dramatic improvements to our street cleaning program. Each year, Public Works budgets \$50,000 for contractual street sweeping, whereby only about 60 curb miles were swept monthly. The program historically only focused on main roads within





Brentwood, most of which were State routes. In the Spring of 2021, the City purchased a street sweeper and began a newly improved program where all curbed sections of main roads and priority areas will be swept at least once per month. Additionally, we have begun sweeping all 388 miles of curbed residential streets on a quarterly basis. Street sweeping is typically geared towards cleaning curb lines, therefore street segments without curbs will not be routinely swept.

With fall quickly approaching, it is important to remember that homeowners are encouraged to mulch or compost leaves. The monthly brush collection program will continue to remove leaves that are placed at the curb in brown paper bags designated for yard-waste. Placement of bulk leaves along the curb line or within designated drainage ways will create flooding issues and can cause costly damage to both private and public infrastructure. The street sweeping program will not collect bulk leaves that are directed into the curb line.

Chipper Service and the Rules

The City of Brentwood offers brush collection once a month to all residents on public and private city streets. This service cost the city roughly \$500,000 annually. The Brentwood Public Works Department implemented the use of grapple trucks in 2019. Since then, the department has asked residents to follow certain rules of where to place debris to ensure the large equipment can safely navigate mailboxes, power lines, and other utility areas.
