

## HOMEOWNER'S WORKERS' COMPENSATION AFFIDAVIT

- I, the undersigned, do hereby swear and affirm that I am applying for a permit with The City of Brentwood Planning & Codes Dept., in Brentwood TN, of Williamson County to have work done on my own personal residence/home listed below.
- I understand that upon obtaining the permit, I am acting as my own contractor, and I am responsible for all work to be accomplished in accordance with any and all applicable codes The City of Brentwood adheres to.
- I confirm that I have knowledge in the basic building principles related to the work associated to the permit I am seeking and will be obtaining.
- I agree with the TN Dept. of Commerce & Insurance T.C.A. .62-6-102, 103 rule, as a homeowner, I am allowed to and <u>will only pull one (1) Resident New Build permit every two (2) years</u> (2 years from date of Notary's Signature). This New Build will be the undersigned homeowner's new home to which they will take up residence (intended for individual/personal use and not sell within the 2 years for business purposes).
- I understand that this affidavit is only applicable towards the permit (description of work) I am applying for. Should I need another permit, I will have to fill out/have notarize another affidavit.
- I understand I <u>cannot pull more than (3) three permits</u> as a homeowner within a year's time of the initial permit pulled (one year from date of Notary's Signature). Permits that fall under this rule include additions, remodels, decks, garages, swimming pools, pool houses, fences, sheds, pergolas, sports courts, etc.
- I understand that I cannot subcontract or hire others to do any plumbing, mechanical or electrical work under the permit for which I am applying. I confirm that I am physically accomplishing work in these fields myself or will be hiring contractors who are skilled in those areas and are permissible in obtaining their own permit in the forementioned fields.
- I understand that I, personally am exempt from the requirement of T.C.A .13-7-211 (proof of Workers' Comp. Insurance), because (check one):
- I solely will be performing work on my own personal residence/home, related to the permit I am applying for. OR

□ I, acting as my own general contractor, will be hiring and/or directly supervising others to work on my own personal residence/home associated to the permit I am applying for (other than plumbing, mechanical and electric). I further understand that while I am acting as my own contractor, I am solely responsible for taking any corrective action against the other parties I allow to work or hire to work, should it deem necessary.
