

City of Brentwood Engineering, Stormwater Control Measures

Inspection and Maintenance Summary Report

IMPORTANT INFORMATION: (Use of this new form is required effective August 26th, 2024)

- An Inspection and Maintenance Summary Report form is required to be submitted annually by the owner (or other authorized personnel) for all Stormwater Control Measures (SCMs) with a grading permit approved after August 26th, 2024.
- The Inspection and Maintenance Summary Report form is required to be completed every 5 years by ALL property owners with a SCM.
- Annual Inspection Summary Reports shall be submitted after January 1st and by no later than July 1st of each year.
- Only one form shall be submitted by each owner (or other authorized personnel) for all the structures on the property. For example, if your property has a bioretention basin and pervious pavers, the site Inspection and Maintenance Summary Report shall include information on the inspection and maintenance on both the bioretention basin and pavers.
- Please note: Owners are required to maintain documentation of routine inspections and maintenance performed throughout the year (i.e. photographs, inspection notes, waste disposal tickets, etc.). This documentation should be submitted to Brentwood.
- This form shall be submitted “electronically” in PDF format to the Brentwood SCM GIS portal or to stormwater@brentwoodtn.gov.
